#### **ASSUMPTION OF RESPONSIBILITY and RISK**

I REALIZE THERE IS RISK OF HARM TO PERSON AND PROPERTY INHERENT IN MY DEPENDENT'S PARTICIPATION IN THE 2023-2024 **KRAKEN STRIKERS VOLLEYBALL CLUB (KSVC)** VOLLEYBALL SEASON, INCLUDING BUT NOT LIMITED TO, TRYOUTS, PRACTICING, PLAYING GAMES AND RELATED TRAVEL.

I freely and voluntarily accept and assume all such risks, dangers and hazards, both usual and unusual, and the possibility of personal injury, death, violence, property damage or loss, during the 2024-2025 KSVC volleyball season and resulting from activities that occur during the same. I acknowledge that there may at times be no access to medical assistance or emergency response. I accept my and my dependent's responsibility to abide by all federal, provincial and municipal laws. I will ensure that my dependent has adequate medical coverage, will protect his/her personal possessions, and will obey all the rules that may from time to time be set out or instructed by KSVC.

#### **RELEASE OF LIABILITY, WAIVER and INDEMNIFICATION**

In consideration of approval to participate in the 2024-2025 KSVC volleyball season, I agree to waive all claims, actions, causes of actions including negligence, claims and demands for damages, loss or injury, that I or my dependent may have now or in the future arising out of my

dependent's participation in the 2024-2025 KSVC volleyball season including, but not limited to, those arising out of damage to any and all property and any and all personal injuries, including death of others, myself or my dependent (the "**Claims**") that I may have against the Kraken Strikers Volleyball Club, its Directors, Coaches, Volunteers, Representatives, Agents, or Sponsors (the "**Club**"). I irrevocably and unconditionally release and forever discharge the Club from any and all such Claims, and I indemnify and hold the Club harmless from all such Claims. I also agree to allow KSVC to use any photographs and/or videos taken of my dependent to be displayed on KSVC website or in any league promotional materials, including but not limited to social media. This agreement and waiver shall be effective and binding on my heirs, next-of-kin, executors, administrators, assigns and representatives.
